## Unfair prejudice and derivative proceedings: tactical considerations

The Companies Act 2006 significantly expanded the scope of traditional shareholder remedies, with many questions about the precise limits of the post-codification rules still being determined today. In this panel, Steven Reed, Timothy Sherwin and Harry Samuels look at unfair prejudice petitions and derivative proceedings, and discuss some practical and tactical considerations for litigators emerging out of the recent case law.

## The Great Escape: How far can interpretation be used to escape contractual obligations in complex or unexpected circumstances?

In a constantly evolving and increasingly dramatic and uncertain international commercial environment, how do commercial parties address their agreements coming up against illegality, impossibility, impracticality or futility? Edward Cumming KC, Ben Waistell, and Niamh Davis discuss a variety of available approaches and the escape routes they may (or may not) provide.



Edward Cumming KC

## **Check Your Privilege**

Sarah Bayliss and Tim Koch review recent cases on privilege including the decision on the 'iniquity exception' by the Court of Appeal in *Al Sadeq v Dechert* [2024] EWCA Civ 28.

Bajul Shah and Erin Hitchens investigate the scope of section 9 of the Arbitration Act following the decision of the Supreme Court in Mozambique v Privinvest [2023] UKSC 32
